## Means of Finance

Consequently, the funding requirements of our Company and deployment schedules are subject to revision in the future at the discretion of our management. Further, in the event of any shortfall of funds for any of the activity proposed to be financed out of the Net Proceeds, our Company may re-allocate the Net Proceeds to the activities where such shortfall has arisen, subject to compliance with applicable laws. Our Company proposes to meet the funding requirements for the proposed objects of the Issue from the Net Proceeds, financial arrangements with the promoters & identifiable internal accruals.

## **Trading of the Rights Entitlements**
